



Dumfries and County Golf Club

Membership Terms and Conditions

1. **Acceptance of Terms:** By paying for an annual subscription, you agree to these terms and conditions.
2. **Changes to Terms:** Changes to these terms may be made from time to time. The latest version will always be available on the Dumfries and County Golf Club website, and members are encouraged to review it regularly.
3. **Rules:** Members agree to abide by the Rules of Golf as governed by The R&A and to adhere to the Dumfries and County Golf Club Code of Conduct.
4. **Membership Fees:** Subscription rates are agreed at The Annual General Meeting in November each year.
5. **Renewal Rights:** Membership shall automatically renew in subsequent years unless the member gives written notice of termination in accordance with these terms.
6. **Non-Refundable Memberships:** Memberships are non-refundable and non-transferable, except where Dumfries and County Golf Club agrees otherwise in accordance with these terms.
7. **Applications for Membership:** Membership applications must be approved by Dumfries and County Golf Club. Membership starts only after approval has been granted and payment has been received. Pro rata subscription rates apply to new applications received throughout the year, based on the joining date.
8. **Renewal Payments:** Renewal payments are due by 31 January each year. If payment has not been made in full, or a payment schedule has not been agreed by this date, membership rights will be suspended until payment is made.
9. **Payment Methods:** Payments can be made by cash, cheque, or credit/debit card.
10. **Payment Schedule:**
 - **Sign-Up:** Members can sign up for a payment plan via the BRS members' app. Available plans will be listed on each member's account. The club does not access members' bank details.
 - **Payment Schedule:** The first payment is immediate, with subsequent payments collected on dates listed within the payment schedule.
 - **Withdrawal:** If a member withdraws mid-year, the remaining balance is due immediately.
 - **Non-Payment:** Failure to pay results in suspension of course access and blocking of the BRS number until the balance is paid.

- **Liability:** Members are liable for the full subscription until all payments are made.
 - **Legal Action:** The club may take legal action for non-payment.
 - **No Extra Charge:** There is no additional charge for the monthly payment option.
 - **Deadline:** All payment plans must be completed before 30th September each year.
 - **Advance Payments:** Can be made via standing order, cash, card, or voucher and held in the member's BRS wallet for future invoices.
11. **Termination of Membership:** Membership terminations must be made in writing or by email to the club administrator. No refunds are given for membership termination within the year unless there are exceptional medical grounds. The final decision rests with Dumfries and County Golf Club.
12. **Use of Facilities:** Membership grants access to club facilities for the relevant year, subject to membership category restrictions and these terms.
13. **Membership Limits:** The club can limit membership numbers, amend tee time allocations, or close the course at its discretion.
14. **BRS System:** Members must provide an email address to use the BRS system for online tee booking. This email address will be used for club communications in line with data protection laws.
15. **Data Protection:** Personal information will be used for membership administration, club communications, and other purposes connected with membership of Dumfries and County Golf Club. It will not be shared with third parties for marketing purposes.
